# Updating the process of recognition for new immigrant nurses

1. An aliyah candidate who does not have an ID card, can open the portal in the Ministry of Health's system for professionals and submit all of the documents even before making aliyah (during the pre-aliyah stage) in order to shorten the recognition process and take the governmental licensing exam immediately upon making aliyah to Israel.

2. A representative from the Nursing Division will examine whether the nurse's education is equivalent to an academic degree in Israel, in conjunction with the Division for Evaluation of Foreign Academic Degrees at the Ministry of Education **Link in Hebrew**:

5. Specialized clinical nurses/ midwives with **at least** a year of professional experience in the field will receive a permanent license to work in nursing immediately after they pass the governmental licensing exam for a certified nurse successfully.
