response to COVID from a workforce perspective.

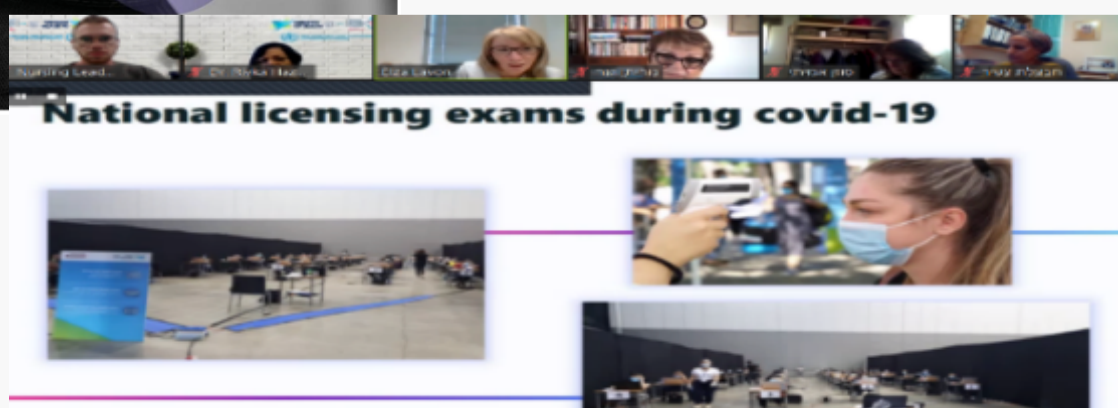
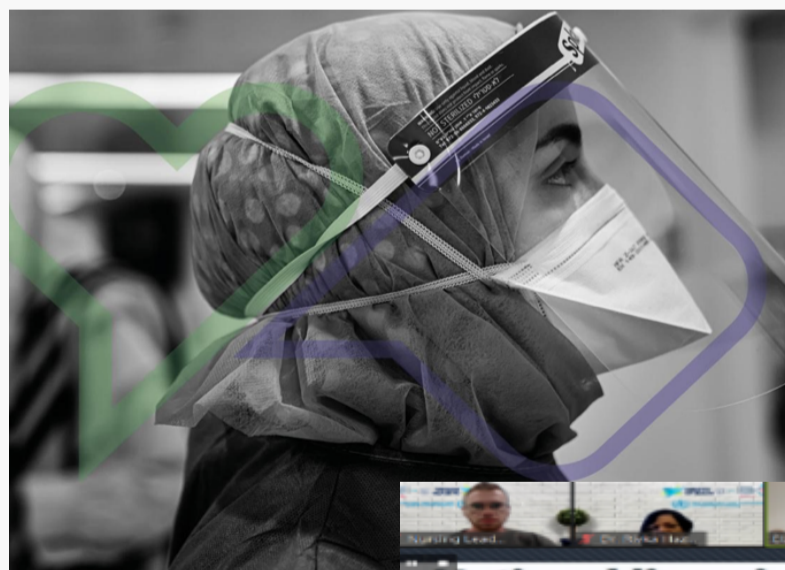
